GENERAL INFORMATION

NCCER Safety Learning Series & OSHA-30 HOUR

Tuition:

\$425.00 per semester (tuition includes cost of manuals); payable in advance to ABC Training Center.

Refund Policy:

- No transfers of tuition to future quarters are allowed.
- Deadline for refunds will be 8:00 p.m. on the first Tuesday following the Safety Orientation.
- A **\$10.00** administrative fee will be charged for any refund other than class cancellation.
- To receive a refund, the trainee **must** submit the original tuition receipt or a copy and complete a “Request for Refund” form.
- If a trainee doesn’t have his/her receipt, then a **\$5.00** administrative fee will be assessed the trainee for a copy of the receipt.
- The refund will then be processed and **mailed** to the trainee within three working days at the address indicated on the “Request for Refund” form.

Evaluation Standards:

Passing	70%
Remediation and Retest	Only one retest per module
Attendance	70%

Note: These standards apply to all unit tests. Students must take and pass all exams and maintain attendance requirements in order to earn the Certificate of Completion & OSHA 30-Hour.

Certificate of Completion & OSHA-30 issued only after successful completion of both “*Field Safety/Safety I*” and “*Safety Technology/Safety II*”—(which is equivalent to: two (2), ten-week semesters).

Class Schedule:

Classes are scheduled 6 p.m. to 9 p.m. Monday- Wednesday or Tuesday-Thursday.



NCCER **SAFETY LEARNING SERIES & OSHA-30 HOUR**

THE ABC TRAINING CENTER OFFERS DUAL-CERTIFICATION—THE NCCER SAFETY LEARNING SERIES AND OSHA-30 HOUR. (THIS COURSE IS ALSO KNOWN AS THE “**CONSTRUCTION SITE SAFETY TECHNICIAN**” CERTIFICATION). ALL STUDENTS WILL BE REQUIRED TO ATTEND TWO 10-WEEK SEMESTERS (*2 nights weekly/6-9 p.m.*) BEFORE ALL CERTIFICATIONS ARE ISSUED.

THE FIRST SEMESTER WILL BE THE **FIELD SAFETY** CLASS. THIS SESSION PROVIDES THE NECESSARY TASK TRAINING TO ALL FIELD PERSONNEL. IT IS DESIGNED FOR INDIVIDUALS INVOLVED WITH COMPLETING OR OVERSEEING A SPECIFIC TASK, FROM THE CRAFTSPERSON, CREW LEADER, SAFETY SUPERVISOR TO SUPERINTENDENT.

THE SECOND SEMESTER WILL BE THE **SAFETY TECHNOLOGY** CLASS. THIS PROGRAM PROVIDES INSTRUCTION ON HOW TO IMPLEMENT AND ADMINISTER A COMPANY SAFETY PROGRAM. IT IS DESIGNED FOR FIELD MANAGERS, SAFETY DIRECTORS, SAFETY COMMITTEES, OWNER SAFETY REPRESENTATIVES AND INSURANCE/LOSS CONTROL REPRESENTATIVES.

SINCE THE SAFETY CLASS IS BASED ON A MINIMUM OF TEN (10) STUDENTS AND DESIGNED TO BE HELD IN TWO 10-WEEK SEMESTERS, THE COST WILL BE **\$425.00** PER SEMESTER (TUITION FEES INCLUDE THE COST OF THE MANUALS).
